Ordinance No. C-11-90-1

AN ORDINANCE AUTHORIZING THE VILLAGE OF NEW CONCORD TO ENTER INTO AGREEMENTS WITH VARIOUS TOWNSHIPS AND VILLAGES IN CLOSE GEOGRAPHIC PROXIMITY TO PROVIDE AMBULANCE SERVICES AND/OR EMERGENCY MEDICAL SERVICES TO THOSE TOWNSHIPS AND VILLAGES AND DECLARING AN EMERGENCY

WHEREAS, the Village of New Concord presently has ambulance services and/or emergency medical services which it provides to Village residents; and

WHEREAS, various local villages and townships have contacted the Village of New Concord to obtain ambulance service, additional ambulance service in times of emergency, or emergency medical service; and

WHEREAS, the provision of ambulance services and emergency medical services to surrounding townships and villages will not prohibit or restrict the Village from providing those services to its residents; and

WHEREAS, it is for the benefit of the Village and its ambulance and/or emergency medical service unit to contract with other townships and villages for the provision of ambulance and/or emergency medical services; and

WHEREAS, this ordinance constitutes an emergency measure for the immediate preservation of the public peace, property, health and safety by reason of the emergency which exists in the Village of New Concord, in that the provision of emergency medical services and ambulance services outside the Village of New Concord shall assist the Village in paying for the equipment and personnel necessary to maintain ambulance services and emergency medical services to the residents of the Village of New Concord, and provides a basis on which the Village may receive reciprocal ambulance and/or emergency medical services for its residents.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEW CONCORD, STATE OF OHIO:

SECTION 1. That the Village of New Concord shall enter into contracts with the following other villages and townships, for the consideration listed below, to provide ambulance and emergency medical services:

Union Township Muskingum County, Ohio	\$2,412.00
Village of Norwich Muskingum County, Ohio	\$ 201.00
Adams Township Guernsey County, Ohio	\$1,100.00
Highland Township Muskingum County, Ohio	\$1,005.00
Rich Hill Township Muskingum County, Ohio	\$ 670.00
Westland Township Guernsey County, Ohio	\$1,100.00

Said contracts shall be in the form attached hereto and all payments due the Village of New Concord by the townships and villages in the amount set forth above shall be paid in two (2) equal installments due on January 1, 1991 and July 1, 1991, respectively.

SECTION 2. That the Village Administrator and Village Clerk be and hereby are authorized to execute said contracts on behalf of the Village of New Concord.

SECTION 3. For the reasons stated in the preamble hereto, which is made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor.


