Ordinance No. C-11-90-2

AN ORDINANCE AUTHORIZING THE VILLAGE OF NEW CONCORD
TO ENTER INTO AGREEMENTS WITH VARIOUS TOWNSHIPS
IN CLOSE GEOGRAPHIC PROXIMITY TO FURNISH
FIRE PROTECTION TO THOSE TOWNSHIPS AND VILLAGES
AND DECLARING AN EMERGENCY

WHEREAS, the Village of New Concord presently has fire
protection services which it provides to Village residents; and

WHEREAS, various local townships have contacted the Village
of New Concord to obtain fire protection service; and

WHEREAS, the provision of fire protection services to
surrounding townships will not prohibit or restrict the Village from
providing those services to its residents; and

WHEREAS, it is for the benefit of the Village and its fire
protection services to contract with other townships for the
provision of fire protection services; and

WHEREAS, this ordinance constitutes an emergency measure
for the immediate preservation of the public peace, property, health
and safety by reason of the emergency which exists in the Village of
New Concord, in that the provision of fire protection services
outside the Village of New Concord shall assist the Village in
paying for the equipment and personnel necessary to maintain fire
protection services to the residents of the Village of New Concord,
and provides a basis on which the Village may receive reciprocal
fire protection services for its residents.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COUNCIL OF THE
VILLAGE OF NEW CONCORD, STATE OF OHIO:

SECTION 1. That the Village of New Concord shall enter
into contracts with the following townships, for the consideration
listed below, to provide fire protection services:

Said contracts shall be in the form attached hereto and all payments due the Village of New Concord by the townships in the amount set forth above shall be payable in advance, in full, before January 1, 1991.

SECTION 2. That the Village Administrator and Village Clerk be and hereby are authorized to execute said contracts on behalf of the Village of New Concord.

SECTION 3. For the reasons stated in the preamble hereto, which is made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor.
