Ordinance No. C-2-89-1

AN ORDINANCE AMENDING CODIFIED ORDINANCE NOS. C-1-84-1, C-6-84-1 and C-5-86-1 RELATING TO FEES FOR COLLECTION AND DISPOSAL OF REFUSE FOR THE VILLAGE OF NEW CONCORD, OHIO.

WHEREAS, Ordinance No. C-1-84-1 was established to regulate garbage and refuse disposal and to establish fees for collection; and

WHEREAS, it is now necessary to amend that Ordinance to increase the fees for collection and disposal of refuse; and

WHEREAS, it is in the best interest of the Village of New Concord and for the preservation of the public health, safety and general welfare of the residents of the Village of New Concord to increase the fees for collection and disposal of refuse; and

WHEREAS, the Village of New Concord does not desire to continue to have a separate fee for the collection and disposal of refuse for senior citizens and Council desires to delete that separate fee from the Ordinances referred to in the title hereto.

NOW, THEREFORE, be it ordained by the Council of the Village of New Concord, State of Ohio as follows:

Section 1. Section 12 of Ordinance No. C-1-84-1; Section 1 of Ordinance No. C-6-84-1; and Section 1 of Ordinance No. C-5-86-1 are hereby amended to read as follows:

SECTION 12. FEES

The fees for collection and disposal of refuse shall not exceed the following:

(a) Single Family Residents: \$7.70 per month

Billings are to be monthly, bi-monthly or quarterly and payable on the 20th of the month the bill is received. There may be a \$2.00 rebilling charge if payment is made after the 20th of the month. Upon non-payment for three months, service may be discontinued.

(b) For hotels, restaurants, colleges, multi-family dwellings and commercial and industrial firms, fees shall

be based upon the average amount of refuse, rubbish or garbage material and the frequency of collection which shall be fixed by the parties provided that if the parties are unable to agree the same shall be fixed by the Health and Sanitation Committee of the Village of New Concord, Ohio. Any increase in the rates shall be subject to prior approval of the Council of the Village of New Concord, Ohio.

Section 2. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
