Ordinance No. C-8-88-1

AN ORDINANCE TO DESIGNATE NO SMOKING IN BUILDINGS AND OTHER ENCLOSED STRUCTURES OWNED BY THE VILLAGE OF NEW CONCORD AND DESIGNATING AN OFFICER WHO SHALL DESIGNATE THOSE AREAS PURSUANT TO REVISED CODE SECTION 3791.031.

WHEREAS, Revised Code Section 3791.031 provides for the designation of non-smoking areas in places of public assembly; and

WHEREAS, said statute provides that all buildings and other enclosed structures owned by a political subdivision including but not limited to office buildings, libraries and museums or a portion thereof may be designated as a no smoking area; and

WHEREAS, said statute provides that the legislative authority of the political subdivision shall designate an officer who shall designate the no smoking areas in said buildings and other enclosed structures; and

WHEREAS, said statute provides that a no smoking area may include the entire place of public assembly; and

WHEREAS, this Council is good cause for designating certain entire places of public assembly as non-smoking and appointing an officer to designate those non-smoking areas hereinafter described.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of New Concord, State of Ohio, that:

Section 1. Purpose. The purpose of this Ordinance is to separate persons who smoke from persons who do not smoke for the comfort and health of persons not smoking, in places of public assembly including buildings and other enclosed structures owned or leased by the Village of New Concord.

Section 2. No Smoking Areas. Village Hall located at 2 West Main Street, New Concord, Ohio and Harper Cabin located at 20 West Main Street, New Concord, Ohio be and hereby are designated as buildings in which no smoking is permitted.

Section 3. Officer of No Smoking Areas and Duties. The Clerk of the Village of New Concord is hereby designated as the officer who shall designate the no smoking areas of the Village of New Concord. That officer shall make no smoking area designations by the placement of signs that are clearly visible and state "No

Smoking". No person shall remove signs from areas designated as no smoking areas.

Section 4. Violation. No person shall smoke in any area designated as a no smoking area.

Section 5. Penalty. Whoever violates any provision of this Ordinance shall be deemed to be guilty of a minor misdemeanor.

WHEREFORE, this Ordinance shall take effect and be enforced from and after its passage and approval by the Mayor.
