

IN THE COUNCIL OF THE VILLAGE OF NEW CONCORD, OHIO

ORDINANCE NO. D-6-87-1

AN ORDINANCE AUTHORIZING AN AGREEMENT BETWEEN THE VILLAGE OF NEW CONCORD AND GUERNSEY-MUSKINGUM ELECTRIC COOPERATIVE, INC. FOR POST LIGHTING FOR STREETS AND OTHER PUBLIC THOROUGHFARES IN WEDGEWOOD SUBDIVISION, VILLAGE OF NEW CONCORD, STATE OF OHIO, AND TO DECLARE AN EMERGENCY.

WHEREAS, Guernsey-Muskingum Electric Cooperative, Inc. has made a certain proposal in writing to the Village of New Concord, Ohio, dated May 29, 1987, offering to provide, furnish, install and maintain lights, posts, fixtures and lighting for streets and other public thoroughfares in Wedgewood Subdivision on the prices, terms, and conditions set forth in said Street Lighting Contract; and

WHEREAS, it is the desire of the Council of the Village of New Concord, Ohio to enter into a Street Lighting Contract with Guernsey-Muskingum Electric Cooperative, Inc. for post lighting and lights, posts and fixtures and in accordance with the provisions and rates specified in the Street Lighting Contract dated May 29, 1987; and

WHEREAS, this ordinance constitutes an emergency measure for the immediate preservation of a public place, property, health and safety by reason of the emergency which exists in the Village of New Concord, Ohio for the reason that there is no street lighting at the present time in the Wedgewood Subdivision of the Village of New Concord, Ohio and the safety of the persons and property of the residents of the Subdivision is in danger.

NOW, THEREFORE, be it ordained by the Village of New Concord, State of Ohio, as follows:

Section 1. That the Street Lighting Contract proposed by Guernsey-Muskingum Electric Cooperative, Inc. dated May 29, 1987, to provide and maintain a street lighting system for the Wedgewood Subdivision of the Village of New Concord, Ohio, a copy of which is on file in the Office of the Clerk and which was presented and read at the Village Council meeting on May 19, 1987 is hereby accepted.

Section 2. That three members of the Council of the Village of New Concord, Ohio be and hereby are instructed to execute an agreement for and on behalf of the Village of New Concord, Ohio, with Guernsey-Muskingum Electric Cooperative, Inc. for such street lighting services on the terms, rates and conditions set forth in said Street Lighting Contract.

Section 3. That for the reasons stated above which are made a part hereof, this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor.
