ORDINANCE NO. D-8-94-1

AN ORDINANCE AMENDING ORDINANCE NO. D-10-93-1, SECTION 1, ESTABLISHING A SCHEDULE OF BASE RATES TO BE COLLECTED BY THE VILLAGE OF NEW CONCORD FROM THE OWNERS OF PROPERTY SERVICED BY THE WATER WORKS OF SAID VILLAGE AND OTHER MATTERS CONNECTED THEREWITH IN ORDER TO OPERATE THE WATER WORKS IN COMPLIANCE WITH THE RULES AND REGULATIONS OF THE ENVIRONMENTAL PROTECTION AGENCY.

WHEREAS, the rates for water services are set forth in Ordinance No. D-10-93-1, and

WHEREAS, the Council of the Village of New Concord must establish new water service rates, and

WHEREAS, it is necessary that revised rates for water service be established; such rates to become effective October 15, 1994, April 15, 1995 and December 15, 1995. These revised charges are necessary for the cost and expense of operating the water system for the Village of New Concord in compliance with rules and regulations of the Environmental Protection Agency.

NOW, THEREFORE, be it hereby ordained by the Council of the Village of New Concord as follows:

Section 1. That all properties within the Village Corporation limits to which a connection is made to the Village Water System shall be charged for water based on water consumption per bi-monthly period, which charges shall be computed as follows:

The minimum water charge per bi-monthly period is \$15.20.

Next	38,000	\$ 3.50
Next	100,000	\$ 3.00
>	150,000	\$ 2.65

The minimum water charge per bi-monthly period is \$17.40.

December 15, 1995

First	4,000	\$ 5.00
Next	8,000	\$ 4.60
Next	38,000	\$ 4.00
Next	100,000	\$ 3.45
>	150,000	\$ 3.05

The minimum water charge per bi-monthly period is \$20.00

(b)

For the service rendered to the Village of New Concord, the same shall be subject to the same rates and charges hereinabove provided, or to charges and rates established in harmony therewith.

Section 2. That the rates and charges set forth herein shall be in full force on the effective dates listed above.


