Ordinance No. D-9-91-1

AN ORDINANCE AUTHORIZING AN EXTENSION OF THE CONTRACT FOR THE PROFESSIONAL SERVICES OF A LICENSED INDIVIDUAL IN OPERATING AND MAINTAINING THE WATER PLANT AND WASTE WATER TREATMENT PLANT OF THE VILLAGE OF NEW CONCORD.

WHEREAS, the Village of New Concord entered into an Agreement authorized by Ordinance No. D-8-90-1 wherein a licensed professional was contracted to operate and maintain the water plant and waste water treatment plant of the Village of New Concord, in compliance with Ohio EPA requirements, to conduct all laboratory analyses required by Ohio EPA, and to maintain the equipment, buildings, and grounds at the water plant and waste water treatment plant; and

WHEREAS, Ordinance No. D-8-90-1 authorized the Village of New Concord to enter into an agreement with Kinder Environmental Services, Inc. to provide professional services in the operation and maintenance of the water plant and waste water treatment plant for a period of one year; and

WHEREAS, said agreement was entered into on September 10, 1990, and under the terms of the agreement, will expire on September 10, 1991; and

WHEREAS, the Village of New Concord and Kinder Environmental Services, Inc. are in the process of negotiating the terms of a new agreement for the operation and maintenance of the water plant and waste water treatment plant; and

WHEREAS, in order to continue said negotiations, the parties have mutually agreed to extend the terms of the agreement entered into by the parties on September 10, 1990, pursuant to the terms of Ordinance No. D-8-90-1, until December 31, 1991.

NOW, THEREFORE, BE IT ORDAINED by the Village of New Concord, Ohio, that:


Section 1. It is hereby determined that the professional services of Kinder Environmental Services, Inc. are professional services which are licensed by the State of Ohio and are services by which competitive bidding is not required.

Section 2. It is hereby declared and determined that the public people's safety and welfare require that the agreement between Kinder Environmental Services, Inc. and the Village of New Concord entered into on September 10, 1990, be extended until December 31, 1991 and that all other terms and conditions of said agreement shall govern the parties for that period. The term of payment during the extension of the Agreement shall be as follows: the Village shall pay Kinder Environmental \$5,691.67 on or before October 10, 1991; \$5,691.67 on or before November 10, 1991; \$5,691.67 on or before December 10, 1991; and \$3,929.32 on or before December 31, 1991.

Section 3. The Village Clerk and Mayor are hereby instructed and authorized to enter into an agreement with said Kinder Environmental Services, Inc., accordingly, and the Clerk is hereby authorized to issue payment for the same. A copy of the agreement dated September 10, 1990, and the extension of that agreement authorized herein shall be placed on file with the Clerk.

Section 4. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.




