ORDINANCE NO. E-9-13-1

AN ORDINANCE AMENDING ORDINANCE E-8-12-1 TO ESTABLISH SALARY RANGES AND WAGES FOR EMPLOYEES AND OFFICERS OF THE VILLAGE FOR THE PERIOD 7-1-13 TO 6-31-14 AND DECLARING AN EMERGENCY.

WHEREAS, it is necessary to establish salaries and wages by ordinance in order to comply with the statutes of the State of Ohio; and

WHEREAS, Village Council desires to adjust the salaries of said Village employees; and

WHEREAS, it is in the interest of the health, safety and welfare of the Village that this Ordinance take effect immediately.


NOW, THEREFORE, be it ordained by the Council of the Village of New Concord, Ohio that:

Section 1. The following salaries for Village employees be and hereby established effective July 1, 2013:






