

IN THE COUNCIL OF THE VILLAGE OF NEW CONCORD, OHIO

ORDINANCE NO. G-4-02-1

AN ORDINANCE TO ACCEPT THE ANNEXATION OF CERTAIN TERRITORY CONTAINED IN UNION AND HIGHLAND TOWNSHIP TO THE VILLAGE OF NEW CONCORD AND ESTABLISHING THE ZONING THEREOF UPON ANNEXATION AND DECLARING AN EMERGENCY.

WHEREAS, a petition for annexation of certain territory in Union and Highland Township was duly filed with the Board of Muskingum County Commissioners on October 25, 2001 by Barbara Hansen, Agent for the East Muskingum Local School District, and

WHEREAS, said petition was duly considered by the Board of County Commissioners of Muskingum County, Ohio on October 25, 2001, and

WHEREAS, on January 22, 2002 the Board of County Commissioners approved the annexation petition and certified the transcript of the proceedings in connection with said annexation with the map and petition required in connection therewith the Village Clerk who received the same on January 25, 2002, and

WHEREAS, sixty (60) days from the date of filing of said transcript with the Village Clerk have now elapsed in accordance with the provisions of R.C. 709.04, and

WHEREAS, the property contained in the annexation petition shall be subject to the Village Zoning Ordinance, and

WHEREAS, the immediate adoption of this ordinance is in the interest of the health, safety and welfare of the Village.

NOW, THEREFORE, be it ordained by the Council of the Village of New Concord, that:

Section 1. That the proposed annexation of certain territory in Union and Highland Township to the Village of New Concord, as applied for in the petition of Barbara Hansen, Agent for the East Muskingum Local School District, contains the signatures of all sole free land holders in the territory sought to be annexed to the Village of New Concord, and filed with the Board of County Commissioners of Muskingum County on October 25, 2001 and which said petition prayed for the annexation to the Village of New Concord of certain territory adjacent thereto as hereinafter described, and which said petition was approved for annexation to the Village of New Concord by the Board of County Commissioners on January 22, 2002, be and the same is hereby accepted. Said territory is described in the attached exhibits labeled Exhibit A-1 and Exhibit A-2.


Section 2. In accordance with the October 25, 2001 agreement between the Village of New Concord and the East Muskingum Local School District, the annexation of the above described property shall take effect in two (2) phases. The annexation of all property described in Exhibit A-1 shall take effect on or before September 1, 2002. The annexation of all property described in Exhibit A-2 shall take effect on September 1, 2004.

Section 3. All property described in Exhibit A-1 and Exhibit A-2 shall be designated in the O-1, Office Institutional Zoning District and shall be subject to the Village Zoning ordinances.

Section 4. The Village Clerk be and hereby is authorized and directed to make two copies of this ordinance to each of which shall be attached a copy of the map accompanying the petition for annexation, a copy of the transcript of the proceedings of the Board of County Commissioners relating thereto and the certificate as to the correctness thereof. The Village Clerk shall then immediately deliver one copy to the Muskingum County Auditor, one copy to the Muskingum County Recorder and one copy to the Secretary of State and do all things required by law.


Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.


